Dear Prospective Vendor:

Please be advised that you must be issued a vendor's license to (1) manufacture or sell retail products bearing Zeta Epsilon Pi Sorority, Incorporated ("Sorority") trademark trade name (Also known as paraphernalia); or (2) sell paraphernalia or different items at any of the Sorority's public functions. You may not use another vendor's license, or allow another to use your license, to manufacture or sell retail products related to the Sorority.

You may apply for this contract by completing the enclosed application and submitting samples, preferably clear photographs of each item you to be licensed. **The application period ends each January 31 of every year.** The license is valid for one calendar year. All licenses expire December 31 of the year issued. Thus, you must reapply for a license annually.

**The license authorizes the Certified Vendor to sell the approved goods to financially active members of the Sorority and** is only issued for products, which sustain and enhance the image of the Sorority. Also, the Sorority reserves the right to revoke or terminate a license should the items sold, in the Sorority's discretion, promote a negative image, includes a design or mark that infringes upon another's intellectual property., is immoral; of poor taste: tarnishes the Sorority's good will, name or trademarks, or is contrary to the views and standards of the Sorority.

Applicants must submit the applicable license fee from the following schedule with the application and samples or photographs to begin the approval process.
